


Works in Progress - Demolition of Old Ramp 3 Caissons at Berth 44/45



Due to the proximity of the works additional towage may be required by vessels arriving and departing from Berths 44 and 45.





The marine plant will be in the following configuration when laying by at Berth 41;

Demolition materials will be offloaded on Berth 47.



All craft will maintain a listening watch on VHF Channel 12 be equipped with AIS and show the required lights and shapes. All vessels should pass at slow speed and make due allowance for their operations and restricted manoeuvrability.

VTS will keep all vessels updated and advise of any relevant information on VHF Channel 12.
