

# PORT INFRASTRUCTURE CHARGES GOODS DUES

Operative: 1st April 2025

#### CONDITIONS

- 1. The rates shown apply to all goods loaded or unloaded.
- 2. Where a shipper, consignor, consignee or agent is planning to move Bulk Liquid, Bulk Solid, Break Bulk or General Cargo through Dublin Port for the first time, confirmation of the applicable Goods Dues charges must be requested from Dublin Port Company in advance.
- 3. In the case of goods: which a shipper, consignor, consignee or agent wishes to move through Dublin Port; which Dublin Port Company agrees can be moved through the port; and for which there is no specified charge set out in the Schedule of Goods Dues, Dublin Port Company will, in advance, set an appropriate rate and update the Schedule of Goods accordingly.
- 4. Where a shipper, consignor, consignee or agent is quoting a third party for moving any goods through Dublin Port, they should first request confirmation from Dublin Port Company as to what Goods Dues charges would apply.
